

TOWNSHIP FILE COPY II

WHEREAS, the Township Supervisors of the Township of Cascade, County of Lycoming and Commonwealth of Pennsylvania, have heretofore adopted a resolution imposing an income tax on certain individuals which said resolution provides for the election of a commissioner of income tax whose duties include the collection, receipts, holding and disbursement of taxes collected and which said resolution also provides for the election of a deputy commissioner whose duties shall be such as are assigned to him by the commissioner; and

WHEREAS, the said Township Supervisors of the Township of Cascade have heretofore elected William S. Collins the Commissioner of Income Tax as aforesaid and have elected James M. Gehrig, Deputy Commissioner of Income Tax as aforesaid; and

WHEREAS, the said Commissioner and Deputy Commissioner collect Income Tax for other political sub-divisions located within Lycoming County, Pennsylvania; and

WHEREAS, by mutual agreement of all of the aforesaid political sub-divisions, it is intended that the Commissioner and Deputy Commissioner shall deposit all income tax collections in one account in the Williamsport National Bank, Williamsport, Pennsylvania, with the proviso that said Commissioner shall have previously entered into an agreement with the Williamsport National Bank and the Federal Reserve Bank of Philadelphia for the pledging of collateral security sufficient at all times to cover the amounts from time to time on deposit with the Williamsport National Bank by said Commissioner and with the authority on the part of the Commissioner or the Deputy Commissioner from time to time to release specific securities pledged as aforesaid.

NOW, THEREFORE, BE IT RESOLVED that the Township Supervisors of the Township of Cascade hereby authorize William S. Collins, its Commissioner of Income Tax, and his successor in said office, and James M. Gehrig, Deputy Commissioner of Income Tax, and his successor in said office, to make collections of the income tax imposed by the resolution heretofore adopted by the Township Supervisors of the Township of Cascade on the 1 day of October, 1965, as amended, to deposit all such collections in one account in the Williamsport National Bank, Williamsport, Pennsylvania, co-mingling said collections with other funds and collections of income tax for other political sub-divisions in said County, and are hereby authorized and required to enter into agreements with the Williamsport National Bank, Williamsport, Pennsylvania, and the Federal Reserve Bank of Philadelphia, Pennsylvania, for the pledging of collateral security in such amounts as will at all times be equal to the total amount on deposit with the Williamsport National Bank as aforesaid, and are hereby authorized from time to time subject to the above requirement to release specific securities pledged as aforesaid, with the authority on the part of the Commissioner or the Deputy Commissioner from time to time to release specific securities pledged as aforesaid.

NOTICE OF INTENTION TO ADOPT
TAX RESOLUTION LEVING A TAX
ON EARNED INCOME

Notice is hereby given that, pursuant to the terms and provisions of the Act of the General Assembly of the Commonwealth of Pennsylvania, approved June 25, 1947, P. L. 1145, No. 481, its supplements and amendments, the Township of Cascade, Lycoming County, Pennsylvania, intends to consider at a meeting of the Township Supervisors to be held in the Township Building, Cascade Township, Pennsylvania, on October 1, 1965, at 8:00 o'clock P.M., for final adoption, a Resolution levying, assessing and collecting a tax for general township purposes of one-half of one per cent on (a) all salaries, wages, commissions and other compensations earned upon and after the first day of January, 1966, by residents of the Township of Cascade, and (b) all profits of business, professions or other activities earned on and after the first day of January, 1966, conducted by residents of the Township of Cascade.

In the judgment of the Township Supervisors, the levy, assessment and collection of said tax is necessary to provide general revenue for the operation of the township.

The ordinance shall become effective on January 1, 1966, and shall remain in effect until December 31, 1966, inclusive; and it is estimated that the amount of revenue to be derived from the imposition of said tax for the year 1966 is Nine Hundred Dollars (\$900.00).
