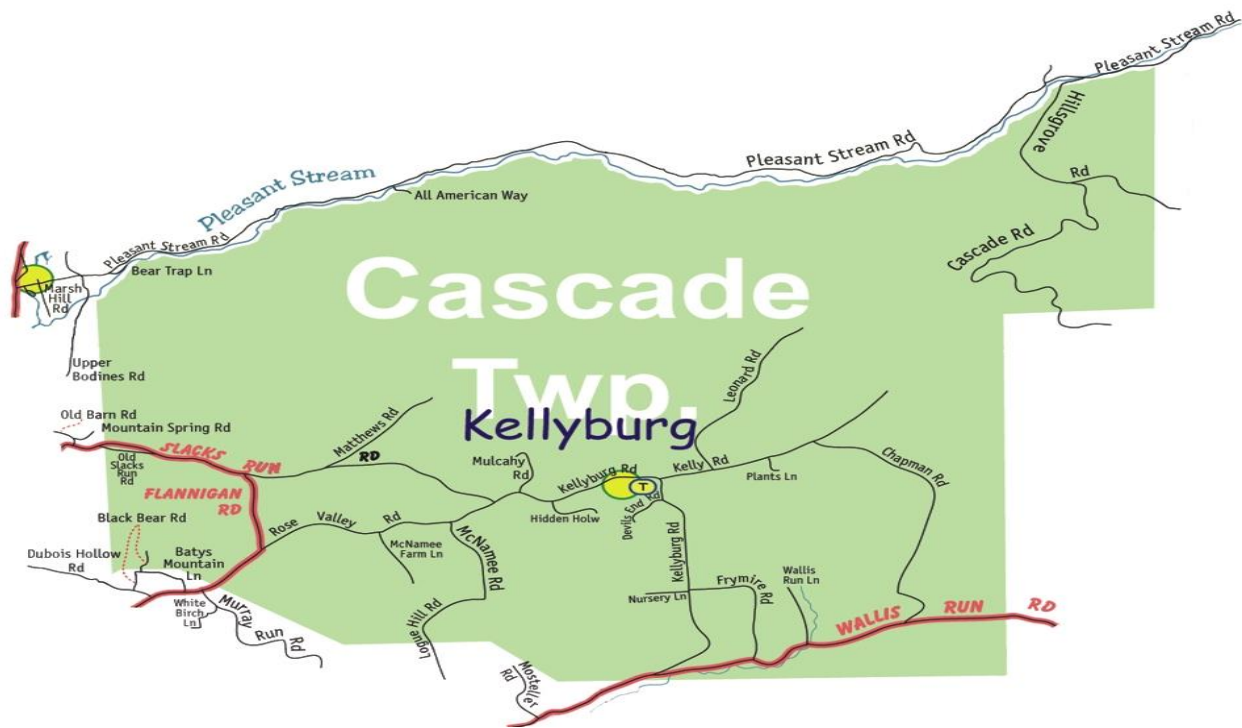

Codes Inspection: Code Inspections Inc. has a web-site where building code permit applications are available to download in PDF (Adobe) format. Please visit www.codeinspectionsinc.com and click on permit and inspection information. You will find commercial information followed by residential information.

When do you call Codes Inspection for a Permit: You need Codes Inspection for any building, electrical, plumbing, mechanical, fire, energy, accessibility and property maintenance, installation, and improvements. A new building with any of the previously mentioned or an older home or building that is being redone with any changes to the previous mentioned you need a building permit.
